Bids which are incomplete not sealed, not signed and stamped, late or submitted by other than specified mode will not be considered.

All prospective firms are required to collect tender documents on any working day during office hours immediately after the first publication of this tender notice in national newspaper against Bank Draft / Pay Order of Rs. 2000/- for each tender in favor of Director General, Punjab Forensic Science Agency, Lahore.
